It is understood by the Applicant the terms of this Application for Prepaid Green Fees Permit (hereinafter referred to as Permit) as follows:

1. The Greens at Hamilton Run Golf Course is a municipal facility owned and operated by the City of Hagerstown, Maryland, a municipal corporation existing under and by virtue of the laws of the State of Maryland.

2. The Applicant/Payer does not have any interest or right in said golf course.
3. The Applicant will act in a lawful manner while utilizing the golfing facilities and in addition thereto, abide by all rules, regulations and procedures promulgated and established pertaining to the Golf Course by the City of Hagerstown, Maryland. Following this application is a copy of our course rules that shall be followed. Failure to do so can result in revocation of pass at the City's discretion.
4. The Applicant further agrees that, violation of any one or **more of the rules, regulations, conditions, etc., results in a revocation or suspension of the privilege of** utilizing the Golf Course for a period of time or permanently, within the absolute discretion of the Parks & Recreation Manager.
5. It is recognized by the undersigned on behalf of himself/herself who may be entitled to exercise the privileges under this Permit that the Golf Course may, in the future, be closed.
6. The undersigned does also recognize and agree that the prepayment of green fees set forth herein and the obtaining of an actual green fees permit does not guarantee the Applicant any preferences in availability of starting times, and/or playing time on said Course.
7. It is understood that by virtue of purchasing this prepaid green fees season pass that the recipient receives only the benefit of paying a reduced fee for green fees. It does not apply to carts.
8. The season pass is valid for play on weekdays, and on weekends and holidays after Noon. The use of season passes before Noon requires payment of additional fee.
9. The season pass rate will not be prorated for any reason including but not limited to sickness, maintenance, weather, other closings, etc. this permit is for green fees only and is non-transferable.
